### Overview

The primary feature of the package is inventory and program catalog management. The focus is based on repeat sales of program items either from stock or drop-shipped from an outside vendor. Emphasis is on recording sales, quantity shipped and purchase cost of inventory items.

The processing of Fulfillment Orders includes the ability to ship direct from inventory or drop ship the goods from an outside vendor. Both House and Customer Owned inventory processes are supported. Other unique features include the ability to enter credit card information on the order, create consolidated invoices, multiple ship-to addresses, tax codes and real time inventory tracking. Sales/Activity reporting can be done by item, program catalog, customer, ship to, and geographically by regions.

Inventory reporting and analysis is significantly enhanced as compared to the standard inventory reporting features offered in Profitmaker. Both First-In First-Out (FIFO) and Last-In First-Out (LIFO) cost accounting is supported. Analysis of standard cost, actual cost and costing trends are available by item, program, product codes and several other selections. Other reports provide information regarding inventory movements such as sales, returns, usage and adjustments by item, program catalog, product codes and several other options. Many of the reports can be used to provide information back to the corporate sponsor of the program suppressing costing information.

### Program Master

- Tracking of sales, cost, and movement activity with summary by program.
- Controls general ledger posting affect, if desired.
- Controls consolidated vs. individual invoicing options.
- Selection of forms required to print for each program.
- Can be designed to limit customers who can purchase through this program.

### Item Master

- Tracking of sales, cost, and movement activity with summary by item.
- Controls general ledger posting, if desired.
- Variable method of inventory allows for shipping from stock or drop shipping the item directly from your vendor in fulfillment order entry.
- Personalization can be selected for in-house , outside or no processing. Depending on the selection

an in-house production order or drop ship purchase order will show the personalization information.

- Simplified creation and maintenance of wearable items.
- Creation of multiple vendors for each item with individual purchasing information.
- LIFO/FIFO method of inventory cost with detailed tracking records.
- Ability to create multiple pricing structures by program.
- Commission % override by item
- Tax override by item

## **Inventory Reporting**

- Ability to run sales and activity reports by program, customer, item and several other selections.
- Item sales reporting by program, customer, ship to, and item number with comparison to last year on a month by month comparison.
- Item activity detail/summary reporting by user defined period.
- Back order tracking.
- Below minimum reporting.
- Suggested reorder summary to inform customers when forms need reordered.
- Forms Management Summary to show customer valuable information to keep them current with their forms inventory.
- Budget Summary reporting for cost centers.
